Dog racing has blood on its hands. After decades of denial, American greyhound breeders have been caught red-handed. We now have video evidence to show that live lure training isn't a myth. It's a terrible reality. And that's why we are going to Washington, DC with our fight to end dog racing!

GREY2K USA investigators have revealed a multi-state conspiracy of cruelty involving the torture and killing of innocent rabbits to "blood greyhounds." In **live lure training**, small animals are used to excite and enhance a chase instinct in young dogs. **Typically, screaming animals are dangled before starving greyhounds, dragged in front of them on ropes, or simply let loose to be attacked.** In March, June and July 2020, our investigators caught greyhound breeders sacrificing dozens of rabbits on farms in Oklahoma, Texas and Kansas.

At breeding kennels, female greyhounds are artificially inseminated and made to pump out litter after litter until they can produce no more. Their little puppies are taken away and kept in outdoor pens. There are no beds for them, no toys and no play. At the age of one, young dogs are sent out to race, where they face death at every turn. According to state records, thousands break their necks, their legs, suffer paralysis, head trauma, seizures and more – all so that someone can place a \$2 bet on them.

Since our formation in 2001, we have successfully worked to close down dozens of tracks – from Arizona to Colorado, Florida, Iowa, all the New England States, Guam and most recently, China. Our legislation has saved tens of thousands of greyhound lives and prevented host states from losing millions of dollars to a cruel and dying industry. In Massachusetts, taxpayers lost \$5 million a year subsidizing two dog tracks, and in Florida the tracks themselves lost a combined \$33 million annually!

### Did you know?

The first recognized commercial greyhound racetrack in the world was built in Emeryville, California in 1919 by Owen Patrick Smith and the Blue Star Amusement Company. The track featured Smith's new invention, the mechanical lure, thought to offer a more humane alternative to the live lures used in traditional greyhound field coursing. By 1930, sixty-seven dog tracks had opened across the United States — none legal. Florida became the first state to legalize commercial parimutuel wagering in 1931, triggering a chain reaction across the globe.

Over twenty-five years ago when I first thought of going to law school, I dreamed of the day when I could become an animal protection attorney. It has been my honor to draft legislation and voter questions that have passed in multiple states, and the filing of the US Greyhound Protection Act represents the culmination of my aspirations. Congressmen file bill to ban greyhound racing after brutality reports

Congressmen from California and Tennessee have introduced legislation to phase out greyhound racing nationwide in response to media reports earlier this week that investigators for an advocacy group had documented evidence that breeders in several states, including Texas, used a brutal, illegal method to train greyhounds to race.

The bill, filed by U.S. Reps. Tony Cárdenas, D-Calif., and Steve Cohen, D-Tenn., would amend the Interstate Wire Act of 1961, which governs betting businesses, to end greyhound racing and live-lure training, officials said.

"Greyhound racing is cruel and must end," Cárdenas said. "These docile animals are kept in stacked cages for 20 hours or more a day and are subjected to brutal training practices and races, facing the risk of injury and death at every turn.

My bill allows for a sensible wind-down of an already declining industry that will ultimately outlaw greyhound racing. As a longtime animal welfare advocate, I am committed to always speaking up for the voiceless."

Leaders at GREY2K USA Worldwide, a Massachusettsbased lobbying group, have turned over videos and a written complaint to Texas law enforcement asserting an Elgin-based farm used live-lure training to prepare greyhounds for racing, said Carey Theil, executive director of the group.

After nearly 30 years, the dog racing track at Gulf Greyhound Park in June shut down operations for good, officials with the organization announced at the time, citing a decline in


